Organization Description:

Since 1974 the International Institute of Minnesota has resettled nearly 25,000 refugees in the Twin Cities and remains one of the largest sponsors of refugees statewide. Its immigration and citizenship services helped nearly 13,000 New Americans achieve U.S. citizenship since 2001. IIM's annual Festival of Nations fosters community and honors culture and traditions of 100 unique ethnic communities. From 2012 to 2018, IIM experienced exponential growth, establishing the organization as an expert in education and workforce development for immigrant and refugee communities. With more than 21 million refugees worldwide waiting to begin new lives, and an increasing workforce shortage in Minnesota, IIM's programs continue to be important abroad and in Minnesota.

Position Description:

The Temporary Case Manager will provide direct services to clients of the Unaccompanied Children (UC) program while the case manager is on leave. The UC program provides services to non-U.S. citizens under the age of 18 who are in the custody of the Office of Refugee Resettlement and are reuniting with family members or friends in Minnesota, North Dakota, or South Dakota. The case manager will conduct home studies and provide post-release services. This is a temporary, contract position.

Experience and Qualifications:

- Commitment to the human rights and general welfare of refugees and immigrants.
- Must be capable of working in a fast-paced, multicultural office environment, take initiative, and be able to handle and prioritize multiple assignments at once.
- Must clear FBI criminal background check.
- Must have Bachelor's degree in Social Work and LSW license, or Master's of Social Work and at least LGSW from Minnesota Board of Social Work.
- Must have valid driver's license, insurance, and own car and be willing to transport clients in your vehicle.
- Must be bilingual in Spanish and English.
- Must have flexible schedule and be willing to travel out of state when needed.
- Experience with direct client services (including case management or therapy).
- Strong ability to respond to and manage crisis situations with clients.
- Knowledge of the dynamics of trauma and trauma-informed care.
- Experience in child welfare, family preservation, and/or foster care/adoption and experience working with immigrant populations.
- Knowledge of different systems and how they impact clients such as criminal justice system, immigration system, health and human services.

- Strong written and verbal communication skills.
- Familiarity with Microsoft office programs, particularly Word and CRM databases preferred.

Duties:

- Visit potential sponsors' homes and assess suitability of conditions for a child within 10 days of acceptance of case referral.
- Provide direct services to unaccompanied children including: safety and needs assessment, trauma-informed case management, supportive counseling, transportation, assistance with referrals for housing, food, medical, legal, mental health, and attendance at immigration court hearings.
- Travel to meet with clients throughout Minnesota, North Dakota, and South Dakota as needed.
- Participate in the maintenance and development of the UC program through monthly coordinator calls, meetings, and written reports.
- Maintain organized files and timely, detailed case notes, and client reports.
- Adhere to NASW Code of Ethics.
